

Attività di raccolta, riciclaggio e recupero dei rifiuti

L'azienda raccoglie, ricicla e valorizza un'ampia gamma di rifiuti come plastica, metalli ferrosi (acciaio) e non ferrosi (rame, nichel, alluminio, ecc.), fornendo materie prime secondarie di alta qualità per l'industria della plastica sotto forma di macinato o pellet da vari tipi di rifiuti plastici. L'azienda si concentra su grandi e importanti produttori di rifiuti, offrendo prodotti e servizi di qualità superiore e diventando un cliente e/o un fornitore apprezzato e rispettato.

Nel corso del tempo, l'attività ha avuto uno sviluppo finanziario, logistico e commerciale positivo anno dopo anno, riuscendo a realizzare un profitto annuale, indipendentemente dal contesto economico/ambientale più o meno favorevole. Attualmente si avvale di una rete di fornitori ben organizzata, di personale qualificato e ben formato, riuscendo ad essere fornitore di alcune note aziende europee del settore e ad avere una forte posizione sul mercato in Romania e in Europa. L'azienda possiede le attrezzature necessarie per riciclare un'ampia gamma di tipi di rifiuti, tra cui la plastica (compresi gli imballaggi).

Il patrimonio totale dell'azienda ammonta a oltre 1 milione di euro. Lo spazio di produzione è nuovo, moderno, ben attrezzato e dispone di tutte le autorizzazioni necessarie per un buon funzionamento. Si compone di: un capannone di produzione su struttura leggera di circa 600 mq, spazi di stoccaggio coperti di circa 1000 mq, un impianto elettrico con trasformatore e rete propria di circa 250 kW, piattaforme in cemento e pavimentate per lo stoccaggio di circa 5000 mq, recinzione perimetrale e cancello di accesso, edifici per uffici e altri spazi necessari all'attività.
