Il terreno agricolo è di 33 ettari, divisi in:

- 3,5 ettari vigneto specializzato DOCG con uva sangiovese in fila di l'età media e in buone condizioni vegetative e produttività
- 5,3 ettari di oliveto DOC ettari con alberi da frutto in parte di recente impianto e in parte di antica data
- 4,5 ettari di terreno con discrete pendenze, adibito a prato da pascolo piantumato ad uliveto a spargolo di età media
- 1,8 ettari di seminativo con laghetto da irrigare
- 18 ettari di bosco ceduo, in parte sottoposto a talea, costituito da piante di querce e castagneti a fusto medio.

Oltre a ciò la vendita include una rimessa attrezzi/fienile, un pollaio, un magazzino e l'appartamento del proprietario.

La rimessa attrezzi e fienile di 401 mq si colloca nel piano terra. Ha accesso diretto dall'area esterna senza alcuna porta. È costituito da due grandi locali aperti e delimitati solo dai pilastri di supporto.

Il pollaio si trova al piano terra ed è di 43,6 mq.

Il magazzino è di 38 mq divisi tra piano terra e primo piano di 38 mq.

L'appartamento del proprietario è di 107,1 mq e si trova al primo piano. È una porzione di fabbricato rurale incompiuto con accesso direttamente dall'area esterna attraverso una scala comune. Mancante di qualsiasi opera di delimitazione e finitura, comprensivi di tutti gli impianti, pavimenti, rivestimenti, intonaci e infissi interni ed esterni.
