Miniera d'oro operativa in esplorazione

Il Kirghizistan possiede molte delle più grandi miniere d'oro dell'Asia centrale.

Si trova sulle pendici settentrionali della catena montuosa di Kirghiz, nella parte alta e destra del torrente Karabulak, nella parte centrale dei giacimenti minerali di Bulakashinsky.

Le rocce vulcaniche partecipano alla struttura geologica del sito. rocce rappresentate da andesiti e basalti di andesite, dai loro tufi e dalle clastoliti. Le rocce intrusive sono rappresentate da gabbro-shonkiniti, sieniti-dioriti e granodioriti, che sono fasi separate di un unico complesso intrusivo. Una caratteristica delle formazioni di questo complesso è il loro aspetto a lastra, in leggera pendenza, con angoli di immersione da 10 o a 50 o , nelle rocce vulcaniche-sedimentarie che le circondano.

Con queste strutture e associate alla formazione di zone mineralizzate e corpi minerali del giacimento.

Le mineralizzazioni di oro e rame identificate, così come le zone di beresizzazione e silicizzazione nel sito di Severny, sono confinate direttamente nelle intrusioni di granodiorite o, più spesso, nei loro contatti intrusivi con le rocce vulcanogeniche e intrusive ospitanti.

La larghezza della zona di beresizzazione raggiunge le prime decine di metri. lunghezza tracciata a 400 m. Tra le beresiti, la venatura più intensa silicizzazione, con disseminazione di solfuri di rame, piombo, ferro e molibdeno.

Il giacimento d'oro è in realtà un unico grande giacimento composto da diversi giacimenti d'oro e un giacimento di rame. Il venditore sostiene di avere un alto grado di oro (percentuale di oro per 1 tonnellata). Tuttavia, il campo non è ben sviluppato. Tutti i dati sono stati raccolti dagli ingegneri sovietici e sembra che da allora non sia stato fatto nulla.
