## Esplorazione mineraria dell'oro "Lago Ridley

Il Progetto Ridley Lake Gold è costituito da 196 rivendicazioni minerarie non brevettate, a cella singola e a confine, di cui Richmond detiene il 100% delle quote. Il progetto è situato in posizione centrale all'interno della Swayze Greenstone Belt nell'Ontario centro-settentrionale, nelle municipalità di Rollo e Raney, nella Porcupine Mining Division, più precisamente a 40 km a sud-ovest della città di Foleyet e a 120 km a ovest-sud-ovest della città di Timmins.

Tra le recenti scoperte aurifere significative all'interno dell'SGB ci sono il giacimento di Cote Lake (acquisito da Iamgold nell'aprile 2012 per 585 milioni di dollari) e la scoperta aurifera di Probe Mines Borden Lake (recentemente acquisita da Goldcorp per 526 milioni di dollari), un giacimento d'oro multimilionario situato a circa 23 miglia a ovest. – I primi lavori di esplorazione sulla proprietà risalgono alla prospezione del 1932.

Nell'area centrale della proprietà sono state scoperte due vene di quarzo (Cyril Knight e Aguara Showings) con orientamento est-ovest. Queste vene sono state esposte in superficie per una lunghezza di striature fino a 245 m, con larghezze variabili tra 1 e 3 m. I saggi di queste vene erano molto variabili, con gradi che andavano da tracce fino a 23 g/t d'oro (0,7 once per tonnellata). – Il Progetto è accessibile tutto l'anno grazie a una rete di strade forestali e sterrate e si trova sotto parte di un'importante sequenza di vulcani e sedimenti del primo Precambriano, denominata complesso vulcanico di Swayze o cintura metavolcanica e metasedimentaria di Swayze-Deloro.

– La mineralizzazione dell'oro scoperta finora attraverso le perforazioni diamantate del progetto è associata a una serie di caratteristiche geologiche che includono lo sviluppo di zone di taglio, sistemi di stockwork di carbonato di quarzo e contatti tra flussi felsici e mafici.
